Executive Summary – Phase 2

Financial Background

- **Crorepati Candidates:** Out of the 13 candidates analysed, **5 (38%)** are crorepatis.
- **Average Assets:** The average assets per candidate contesting in Jammu & Kashmir (Phase 2) Lok Sabha 2014 elections is **Rs. 1.49 crores**.
- **High Asset Candidates:** Out of the 13 candidates analysed, **5** candidates have more than **Rs. 1 crore worth of assets**. Total assets include Self Assets and Others' Assets. The top three candidates with highest assets are given below:
