Executive Summary

Financial

- <u>Crorepati Candidates:</u> Out of the 8 candidates analysed, 1 (13%) is crorepati (Rajkumar Ranjan Singh from BJP with an asset of 1.34 crores).
- *Average Assets:* The average assets per candidate contesting from Inner Manipur constituency is **Rs.36.10 lakhs**.
- *Candidates with liabilities:* Only 1 candidate, **Moirangthem Nara, CPI**, has declared liabilities worth **Rs. 27.85 lakhs**
- Candidates who have declared income:
