Executive Summary – Phase 1

Criminal Background

- **Candidates with Criminal Cases:** Out of the 238 candidates analysed, **14 (6%) candidates** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 238 candidates, **5 candidates** have declared serious criminal cases relating to causing hurt to deter public servant from his duty, subjecting a woman to cruelty, etc.
- **Party wise Candidates with Criminal Cases:** **2 (10%)** out of **20** candidates fielded by **BJP**, **2 (10%) out of 20** candidates from **INC**, **1 (6%) out of 17** candidates from **AAP** and **6 (7%)** out of 87 Independent candidates have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **1 (5%) out of 20** candidates from **BJP** and **4 Independent candidates** have declared serious criminal cases against themselves.
- **Candidates with cases related to Crime against women:** **Kumbha Ram**, an Independent candidate from **Ganganagar constituency** has declared one charge related to husband or a relative of a woman subjecting her to cruelty (IPC Section 498A)

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Financial Background

- **Crorepati Candidates:** Out of the 238 candidates analysed, **71 (30%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **18 (90%) out of 20 candidates** each from **BJP** and **INC** are crorepatis, **12 (71%)** out of 17 candidates of **AAP**, **4 (22%) out of 18** candidates from **BSP** and **1 (33%) out of 3** candidates of **SP** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting from Rajasthan – Phase 1 in Lok Sabha 2014 elections is **Rs. 2.66 crores**.
- **Party-wise Average Assets:** Among major parties, the average assets of **20 INC** candidates is **Rs 13.39 crores**, **20 BJP** candidates have an average assets of **Rs 8.50 crores**, **17 AAP** candidates have **Rs 3.30 crores**, **18 BSP** candidates have average asset of **Rs. 77.71 lakhs** and **3 SP** candidates have average asset of **Rs 14.02 crores**.
- **High Asset Candidates:** **11** candidates have more than **Rs. 15 crore worth of assets**. Total assets include Self Assets and Others' Assets. The top three candidates with highest assets are given below:

- Low Asset Candidates:** Out of 238 candidates analysed, a total of **18** candidates have declared assets **less than Rs 1 lakh**. Among major parties, **Sumedha Nand Saraswati** of **BJP** from Sikar constituency declared the lowest asset of **Rs 34 thousand** followed by **Gopal Singh Shekhawat** of **INC** from Rajsamand constituency who declared total assets of **Rs 41.57 lakhs**. The three candidates with lowest assets are as follows:

- Candidates with Liabilities:** A total of 105 candidates out of 238 analyzed have declared liabilities **out of which 10** candidates have declared liabilities **above Rs 1 crore**. **Dr Jyoti Mirdha** of **INC** from Nagaur constituency has declared liabilities of **Rs. 23.09 crores** followed by **Anjana Uday Lal**, also of **INC** from Jalore constituency with liabilities of **Rs 20.25 crores** and **Pramod Kumar**, of **INC** from Jhalawar-Baran constituency declaring total liabilities of **Rs 9.28 crores**.
- Candidates with High Income*:** A total of 126 candidates have declared their income tax details **out of which 7** candidates have declared a total income of more than **Rs 50 lakhs**. **Ijyaraj Singh** of **INC** from Kota constituency has declared the highest total income of **Rs 2.71 crores** followed by **Dr Jyoti Mirdha**, also of **INC**, from Nagaur constituency with a total income of **Rs 2.29 crores** and **Santosh Ahlawat** of **BJP** from Jhunjhunu constituency with a total income of **Rs. 97.52 lakhs**. *Total income includes income of self, spouse and dependents
- Candidates who have not declared Income Tax Details*:** **112 (47%)** candidates out of 238 analyzed have not declared income tax details. *Some candidates may be exempted from filing Income Tax Returns
- Candidates with High Assets who have not declared Income Tax Details:** **11** candidates with declared assets of more than Rs 50 lakhs have not declared Income Tax Details.
- Undeclared PAN:** **69 (29%)** out of 238 candidates analysed have not declared their PAN details.

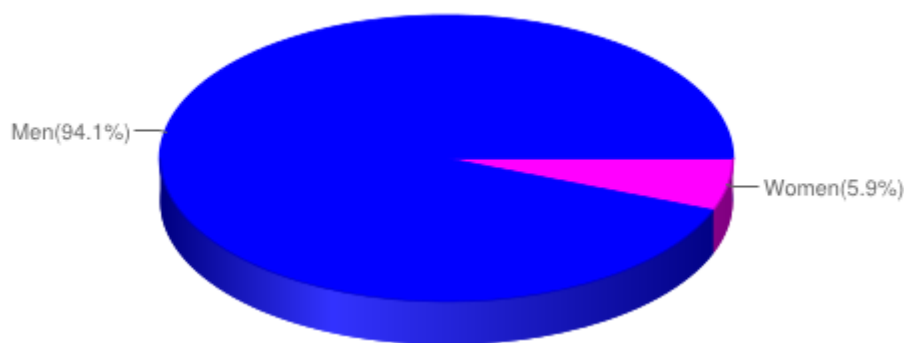
