Association of Democratic Reforms (ADR) and West Bengal Election Watch (WBEW) have analyzed the self-sworn affidavits of all 47 candidates (as given by the ECI) who are contesting the 1st Phase of elections in West Bengal for Lok Sabha 2014.

Executive Summary

Criminal Background

- **Candidates with Criminal Cases:** Out of all 47 candidates analysed, **5 candidates (11%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** All **5 candidates** have declared serious criminal cases including cases related to murder, attempt to murder, criminal intimidation, theft etc.
- **Party wise Candidates with Criminal Cases:** **2 (50%) out of 4** candidates fielded by **SUCI(C)**, **1 (50%) out of 2** candidates from **CPI(M)**, **1 (100%) out of 1** candidate of **AIFB**, and **1 (13%) out of 8 Independent** candidates have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **2 (50%) out of 4** candidates fielded by **SUCI(C)**, **1 each from CPI(M) and AIFB** and **1(13%) out of 8 Independent** candidates have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Murder and Attempt to Murder:** **Bangshi Badan Barman** an **Independent** candidate from **Coochbehar** constituency has declared **3 charges related to Murder(**IPC Section-302**)** and **3 charges related to Attempt to Murder(**IPC Section-307**)**. **Saman Pathak** of **CPI(M)** from **Darjeeling** constituency has declared **3 charges related to Attempt to Murder(**IPC Section-307**)**. **Dipak Kumar Roy** of **AIFB** from **Coochbehar** constituency has declared a charge related to **Attempt to Murder(**IPC Section-307**)**.
- **Red Alert Constituency*:** **1 constituency** namely **Coochbehar** has 3 candidates with declared criminal cases.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

**Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections.*

Financial Background

- **Crorepati Candidates:** Out of all 47 candidates analysed, **9 (19%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **2(50%) out of 4** candidates from **BJP**, **2(50%) out of 4** candidates from **AITC**, **1(100%) out of 1** candidate from **Revolutionary Socialist Party**, **1(50%) out of 2** candidates from **CPI(M)** and **1(25%) out of 4** candidates from **INC** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in the first phase of elections from West Bengal for Lok Sabha 2014 is **Rs.94.40 Lakhs**.
- **Party-wise Average Assets:** Among major parties, the average assets for 4 **AITC** candidates is **Rs 5.25 crores**, 4 **BJP** candidates have average assets of **Rs.1.02 crores**, 4 **INC** candidates have average assets of **Rs. 1.01 crores**, while 4 **SUCI(C)** candidates have average assets of **Rs. 6.54 Lakhs** and 2 **CPI(M)** candidates have average assets of **Rs. 63.27 lakhs**.

- **Candidates with Liabilities:** A total of 17 candidates out of the 47 contesting candidates analyzed have declared liabilities out of which 10 candidates have declared liabilities above **Rs. 5 lakhs**. **Bhaichung Bhutia** of AITC from Darjeeling constituency has declared liabilities worth **Rs. 77.46 Lakhs** followed by **Mahendra Prasad Lama** an Independent candidate from Darjeeling constituency with liabilities worth **Rs. 39 Lakhs** and **Satyajal Sarkar** of BJP from Jalpaiguri constituency with liabilities worth **Rs. 12.67 Lakhs**.
- **Candidates with High Income:** 6 candidates have declared total annual Income of **over Rs.10 Lakhs**. **Bhaichung Bhutia** of AITC from Darjeeling constituency has declared the highest total income of **Rs. 76.34 Lakhs** followed by **Surendrajeet Singh Ahluwalia** of BJP from Darjeeling constituency with **Rs. 25.42 Lakhs** and **Mahendra Prasad Lama** an Independent candidate from Darjeeling constituency with **Rs. 15.72 Lakhs** of total income. **Total income includes income of self, spouse and dependents*
- **Candidates who have not declared Income Tax Details*:** 20 (43%) candidates out of the all 47 contesting candidates analyzed have not declared income tax details. ** Some candidates may be exempted from filing Income Tax Returns*
- **Candidates with High Assets who have not declared Income Tax Details:** 4 candidates with assets worth more than Rs. 50 Lakhs, have not declared Income Tax Details.
- **Undeclared PAN:** 6(13%) out of all 47 contesting candidates analyzed have not declared their PAN details.

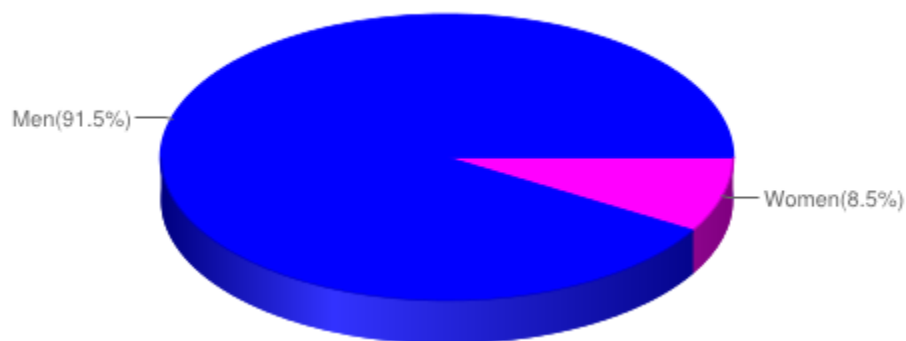
