Asset Comparison of Re-contesting MLAs in Punjab 2012 Assembly Elections

- Punjab Election Watch (PEW) has analyzed affidavits of 77 re-contesting MLAs.
- 18 MLAs out of these 77 re-contesting MLAs have pending criminal cases against them
- 5 re-contesting MLAs out of these 77 have serious criminal cases like murder, attempt to murder, kidnapping, robbery etc. pending against them.
- The average assets of these MLAs as declared in 2007 is Rs 4,60,37,351 (4.6 crores)
- The average assets of these MLAs as declared in 2012 is Rs 10,73,33,640 (10.7 crores)
- Average asset growth for these re-contesting MLAs is Rs 6,12,96,289 (6.1 crores)
- Average percentage growth in assets for these MLAs is 133%

Chandigarh/Delhi, January 19th, 2012: Association for Democratic Reforms (ADR) and National Election Watch (NEW), a nationwide campaign comprising of more than 1200 NGOs and other citizen led organizations, has been working on electoral reforms, improving democracy and governance in India.

Punjab Election Watch (PEW) has analyzed and compared affidavits of 77 re-contesting MLAs in the Punjab Assembly Elections 2012 with their available affidavits from 2007 Assembly Elections. This report is based on the above comparison. It describes the pending criminal case details of re-contesting MLAs and also compares their asset values/increase from the declarations of 2007 with declarations made in 2012.

Analysis based on pending criminal cases

Analysis based on pending criminal cases –Re-contesting MLAs

PEW has analyzed affidavits of 77 re-contesting MLAs . 18 MLAs out of these 77 re-contesting MLAs have pending criminal cases against them, and 5 re-contesting MLAs out of these 77 have serious criminal cases pending against them.

Party- wise break up of re-contesting MLAs with pending criminal cases

Out of total 77 re-contesting MLAs with pending criminal cases, 10 are from INC, 7 from SAD and 1 is from BJP.

Serious crimes distribution for major parties- Re-contesting MLAs

There are several cases of violent crimes like murder, attempt to murder, kidnapping, robbery etc pending against the re-contesting MLAs in Punjab 2012 Assembly Elections. The table below gives a summary of all serious violent offences related to murder, attempt to murder, kidnapping, robbery etc. As can be seen from the table MLAs of INC has 5 serious IPC counts against them, while MLAs from SAD have 2 serious IPC counts against them.

Average asset increase for re-contesting MLAs-Party-wise

The table below provides the party-wise average asset increase of re-contesting MLAs. Financial details of 37 re-contesting MLAs of INC are available from affidavits of 2007 Assembly Elections. These were matched with available affidavits of 2012 to reveal that the average asset increase for each re-contesting MLAs of INC is Rs 6.81 crores. The same procedure was followed for other parties and it was found that the available details for 28 re-contesting MLAs of SAD show an average asset increase of Rs. 4.74 crores each. Given below is the detail for all parties who have re-contesting MLAs in Punjab Assembly Elections 2012:

Asset comparison of re-contesting MLAs

The table below provides the increase in assets of re-contesting MLAs. In Rupees, the maximum growth in assets has been for Kewal Singh Dhillon of INC. His assets have grown by over 71.67 Crores. He is followed by Sukhpal Singh of INC (asset growth of over 50.45 Crore) and S. Shukhpal Singh Nanu of BJP (asset growth of over 47.8 Crore).
