# **Punjab 2007 Assembly Elections**

Punjab Assembly Election, 2007 was held on 13<sup>th</sup> February, 2007. A total of 1055 candidates contested in the Punjab State Assembly Elections. Punjab Election Watch (PEW) & Association for Democratic Reforms (ADR) have analyzed the data of 351 candidates, which consists of winners, 1<sup>st</sup> and 2<sup>nd</sup> runners up of the 2007 Punjab State Assembly Elections. This report includes the analysis of criminal, financial, educational and other details of these candidates. Information provided by the Election Commission of India and details from the affidavits filed by the candidates have been used for the analysis.

# **Representation of political parties**

In Punjab 2002 Assembly Elections, 32 political parties contested which increased to 36 in the Punjab 2007 Assembly Elections. This reflects an increase of 11% in the number of political parties contested in 2007 elections compared to 2002 elections.

## Growth in number of candidates

Out of 1055 candidates contesting in 2007 Assembly Elections, there were 999 (95%) men and 56 (5%) women candidates. In 2002, out of 923 candidates who contested, 852 were men (92%) while 71 (8%) were women. Hence, the percentage of women candidates has decreased by 21% from 2002 Assembly Elections to 2007 Assembly Elections.

## **Executive summary of candidates**

- Punjab Election Watch (PEW) analyzed affidavits of 351 candidates (which include all winners, 1<sup>st</sup> and 2<sup>nd</sup> runners up) out of 1,055 who contested 2007 Assembly elections.
- Out of these 351 candidates analyzed, 56 candidates or 16% declared pending criminal cases against them.
   SAD had 29 out of 94 (31%), INC had 14 out of 117 (12%), BSP had 5 out of 58 (9%), BJP had 2 out of 23 (9%),
   SAD(M) had 1 out of 2 (50%), CPI had 1 out of 13(8%) and LJP had 1 out of 1 (100%) candidates analyzed with pending criminal cases against them.
- Out of these 56 candidates with pending criminal cases, 18 had pending serious criminal cases against them like murder, attempt to murder, kidnapping, robbery, extortion etc. SAD had 9, INC had 4, BSP had 2, LJP had 1 and SAD(M) had 1 candidates with pending serious criminal cases against them.
- Out of these 56 candidates with pending criminal case, 20 won the elections. Out of these 20, 11 were from SAD, 7 from INC and 2 from BJP.
- There were 31 IPC charges of heinous nature on the candidates analyzed which included murder, attempt to murder, kidnapping, extortion, etc.





- A total of 176 candidates out of 351 analyzed i.e. 50% were crorepatis.
- Out of these 176 crorepatis, 78 (44%) won the elections. Out of 78 crorepaties won elections, 33 were form INC, 31 from SAD, 10 from BJP and 4 were Independent candidates.
- A total of 32 (9%) candidates out of 351 analyzed, had declared liabilities of Rs 25 lakhs or above.
- Among major parties, the average asset per candidate for SAD (M) was Rs. 5.67 crores, for SAD it was Rs.4.19 crores, for INC it was 3.71 crores, for BGTD it was 2.40 crores and for BJP it was 2.09 crores.
- 33% of candidates (116 out of 351 analyzed) had not furnished PAN card details.
- More than 48% of candidates (168 of 351 analyzed) were graduates or with higher educational qualifications.

# Analysis based on pending criminal cases

#### Analysis based on pending criminal cases- candidates

A total of 351 affidavits were analyzed by Punjab Election Watch (PEW) for 2007 Assembly elections. Out of the 351 candidates, 56 or 16% declared pending criminal cases against them. Out of these 56 candidates with pending criminal cases, 18 had serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc. pending against them.

## Party-wise break up of candidates with pending criminal cases

A total of 56 candidates (out of 351 analyzed) contested elections from Punjab had pending criminal cases against them. Out of 117 candidates of INC, 14 (12%) had pending criminal cases against them, 29 out of 94 (31%) from SAD, 5 candidates out of 58 (9%) of BSP and 2 out of 23 (9%) candidates of BJP had pending criminal cases against them.

# **Analysis of Winnability**

# **Chances of winning based on Party**

- Winners from SAD, INC and BJP constitute 96% (i.e. 112 out of 117) of the total winners in Punjab 2007 Assembly Elections.
- 1<sup>st</sup> runners up of 2007 assembly elections from INC, SAD and BJP constitutes 98% (i.e. 115 out of 117) of the total 1<sup>st</sup> runners up.
- Winners and 1<sup>st</sup> runners up from SAD, INC and BJP constitute 97% (i.e.227 out of 234) of total winner or runners up.
- This clearly shows that in 2007 Punjab Assembly Elections, getting a ticket from SAD, INC or BJP had ensured the candidates of becoming winner or first runner up.
