# Punjab Election Watch\*

## Lok Sabha elections 2009

Lok Sabha 2009 elections were held in 2 phases in Punjab on 7 May 2009 and 13 May 2009. This chapter includes the analysis of voting trend, criminalization, money power, gender, etc in these elections. Information provided by ECI and details from the affidavits filed by the contesting candidates have been used for above analysis.

### **Growth of political parties**

In Lok Sabha 2004, 21 parties contested elections which rose to 31 in Lok Sabha elections 2009. This reflects a rise of 48 % in the number of parties from Lok Sabha 2004 elections to Lok Sabha 2009 elections.

### **Growth in number of candidates**

In Lok Sabha 2004 Elections, the total number of candidates contesting elections for 13 seats in the State was 142, which rose to 218 in the 2009 elections. The state witnessed an increase in number of candidates by 76 or 54%.

## **Executive summary for candidates and MPs**

### **Summary for candidates**

- A total of 218 candidates contested Lok Sabha 2009 elections from Punjab.
- Out of these 218 candidates, 19 candidates or 9% declared pending criminal cases against them. Out of 13 candidates of INC, 1 (7.69%) had pending criminal cases. 1 candidate out of 10 candidates of SAD (10%) and 1 candidate out of the total 3 candidates of BJP (33.33%) had declared pending criminal cases.
- Out of these 19 candidates with pending criminal cases, 12 had pending serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc.
- There were 31 IPC charges of serious nature on the candidates which included murder, attempt to murder, kidnapping, extortion, etc.
- There were 3 red alert constituencies where 3 or more candidates had pending criminal cases.
- A total of 49 candidates out of 218, i.e. 22.48% were crorepatists.
- A total of 4 candidates declared zero assets.
- A total of 34 candidates declared liabilities in excess of Rs. 5 lakhs.
- Average assets for candidates of BJP, INC and SAD were approximately about Rs. 17.29 crores, Rs. 9.71 crores and Rs. 3.38 crores respectively.

- A total of 126 out of 218 candidates i.e., 57.8% had not furnished PAN details.
- Out of the 218 candidates, only 13 women candidates or 6% contested elections.
- Only 26.6 % of the total candidates (58 out of 218) were graduates & above.
- INC managed to get 45% of the votes polled and 32% registered voters. SAD secured 34% of the total votes polled and only 24% of the registered voters. About 89% of the votes polled went in favor of BJP, SAD or INC

## **Summary for MPs**

- Out of the 19 candidates with pending serious criminal cases against them, only 1 managed to win, and rest all were rejected by the voters.
- Out of the 13 MPs from Punjab, 2 have pending criminal cases against them. Compared to Lok Sabha 2004, there has been a decline in number of MPs with pending criminal cases. There were 5 MPs with pending criminal cases in Lok Sabha 2004.
- All 13 MPs from Punjab are crorepatists.
- The average assets for MP of INC, SAD and BJP were Rs. 8.37 crores, Rs. 2.16 crores and Rs. 14.36 crores respectively.
- Out of the 13 MPs, 1 MP had not furnished PAN details.
- Out of the 13 women candidates, 4 managed to win. 31% of MPs from Punjab in current Lok Sabha are women.

# Voting and winning trend

## Voting Analysis

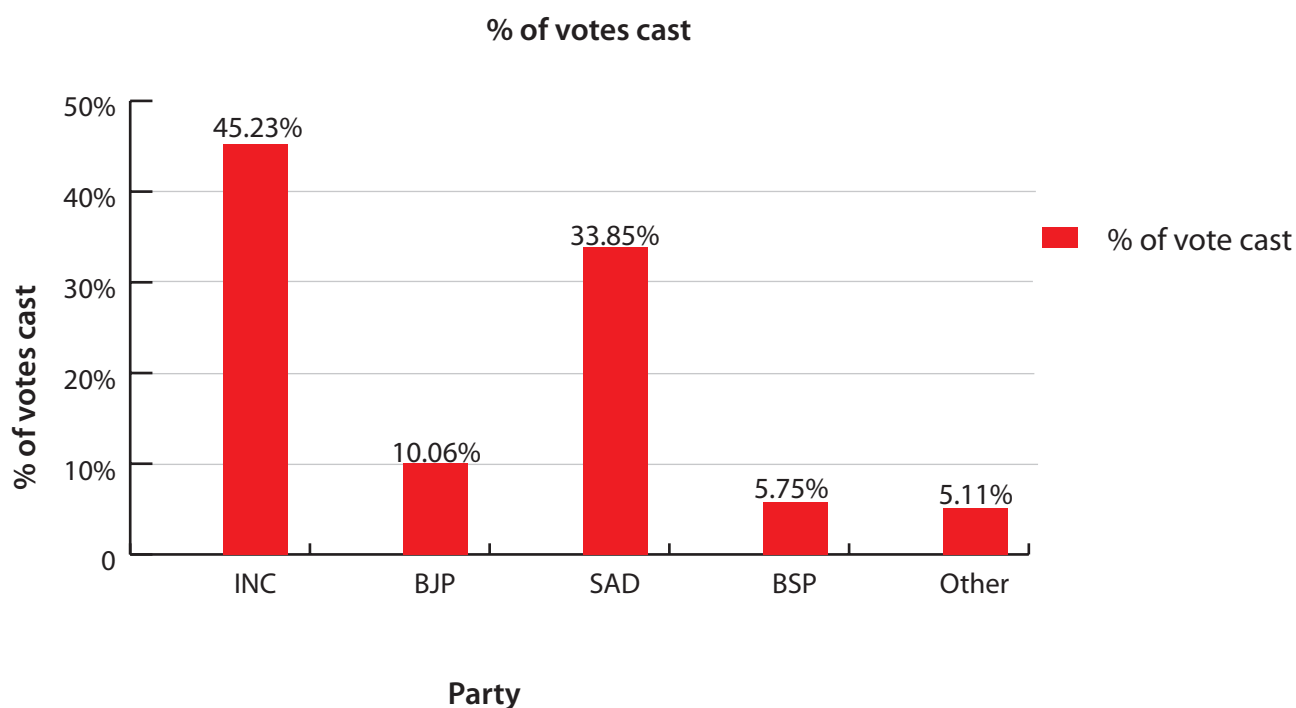
Total voting in the state was 70%. INC managed to get 45% of the votes cast and 32% registered voters. BJP secured 10 % of the total votes cast and only 7% of the registered voters. SAD secured 34% of the total votes cast and only 24% of the registered voters. About 89% of the votes cast went in favor of BJP, SAD or INC. Other political parties and independent candidates did not receive a sizable amount of votes polled. The total electorate in Punjab was 1, 69, 58,378 and the total votes cast were 118, 29,304.

**Figure : Per cent of votes cast in punjab - party wise**



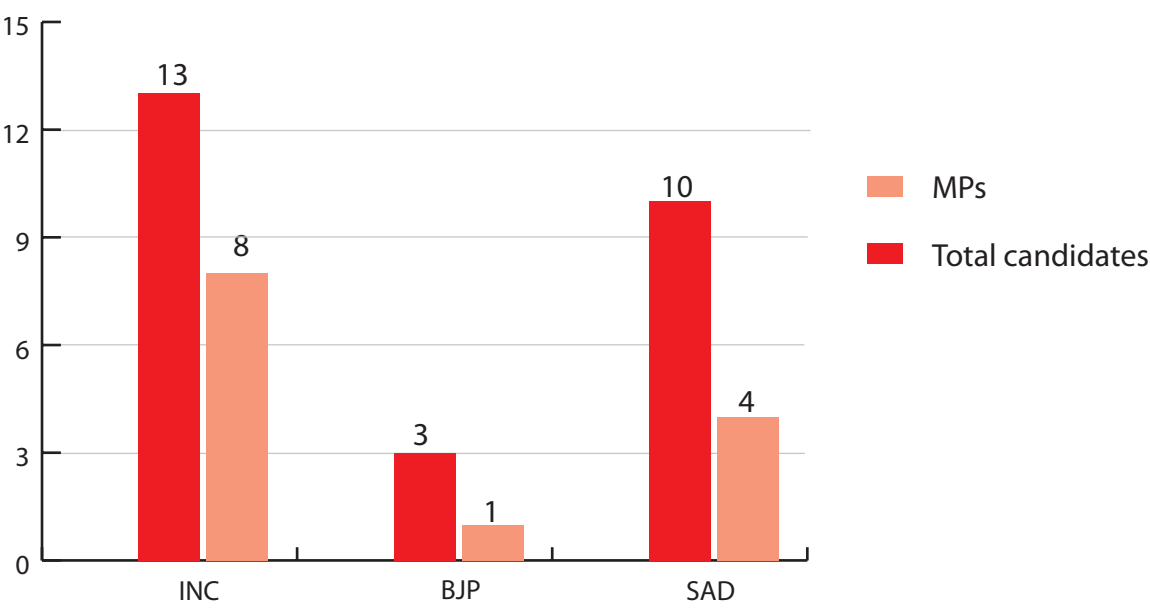
# Contestants Vs MPs

# Analysis based on pending criminal cases

## Pending criminal cases- analysis for candidates

Out of the 218 candidates, 19 candidates or 9% declared pending criminal cases against them. Out of these 19 candidates with pending criminal cases, 12 had pending serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc.

## Party wise break up for candidates with pending criminal cases

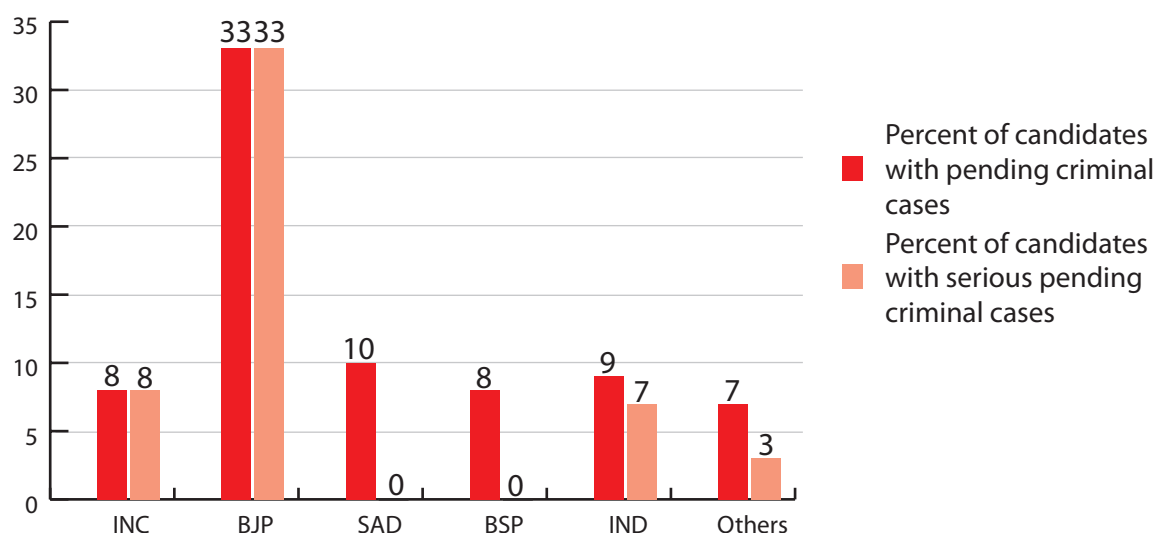
Total 19 candidates contesting elections from Punjab had pending criminal cases against them. Out of 13 candidates of INC, 1 (7.69%) had pending criminal cases. 1 candidate out of 10 candidates of SAD (10%) and 1 candidate out of the total 3 candidates of BJP (33.33%) had declared pending criminal cases.

Out of these 19 candidates with pending criminal cases, 12 had pending serious criminal cases against them. These serious cases include murder and related charges, kidnapping, extortion, dacoity, theft, robbery etc. The break up is given in the table below.

Figure: Serious IPC section break up for candidates of major parties

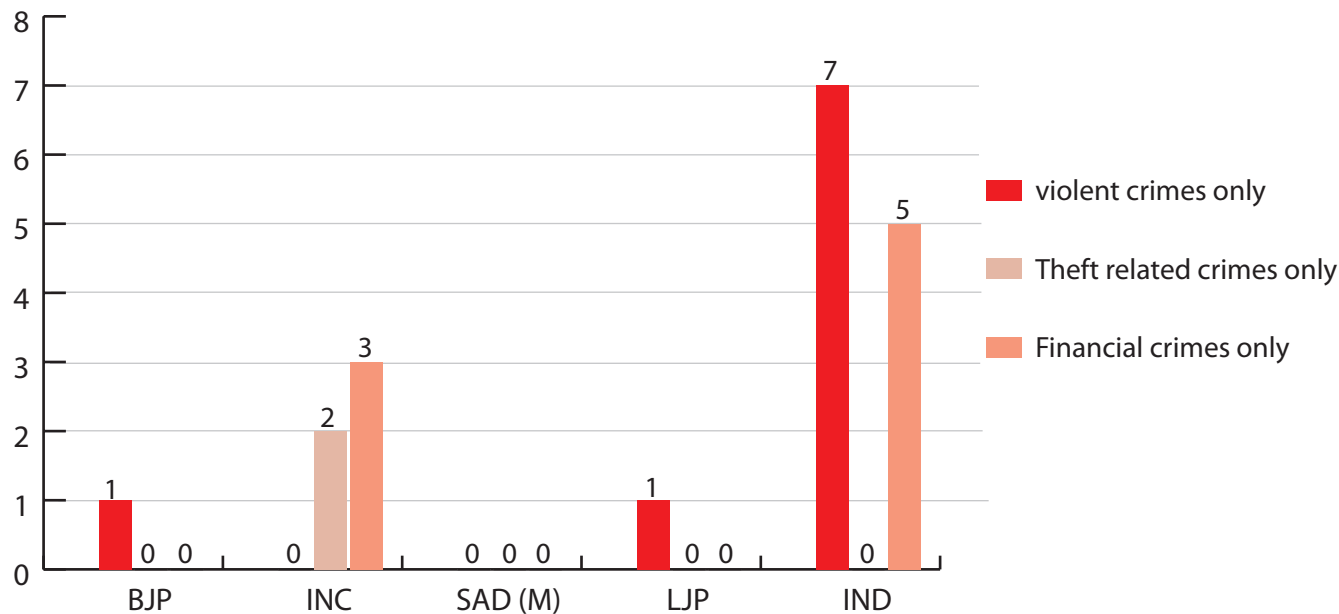
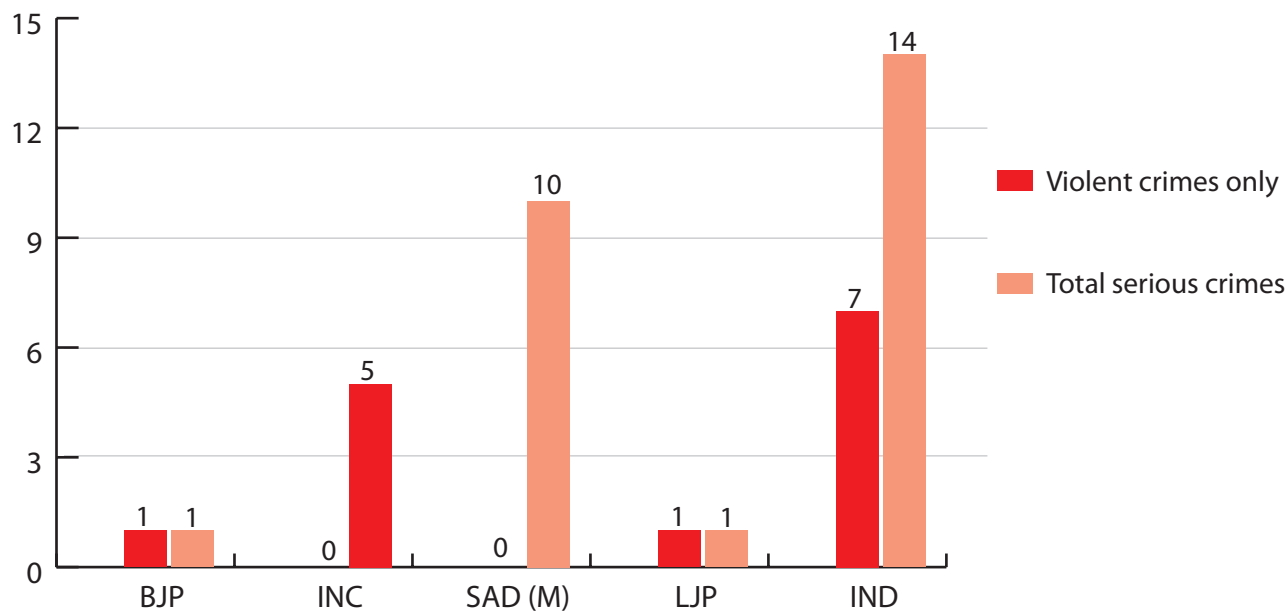


Figure: Comparison of total serious crimes vs. total violent crimes (murder, kidnapping, etc)-Party wise



## Party wise comparison of pending criminal cases on candidates in Lok Sabha 2004 & Lok Sabha 2009

A comparison between Lok Sabha elections 2009 & 2004 for candidates of four major parties and with pending criminal cases shows an interesting trend. The number of candidates with pending criminal cases has decreased in 2009 elections as compared to 2004 elections for INC and SAD. The number of candidates with pending criminal cases remained constant for BSP and BJP.

## Pending criminal cases- analysis for MPs

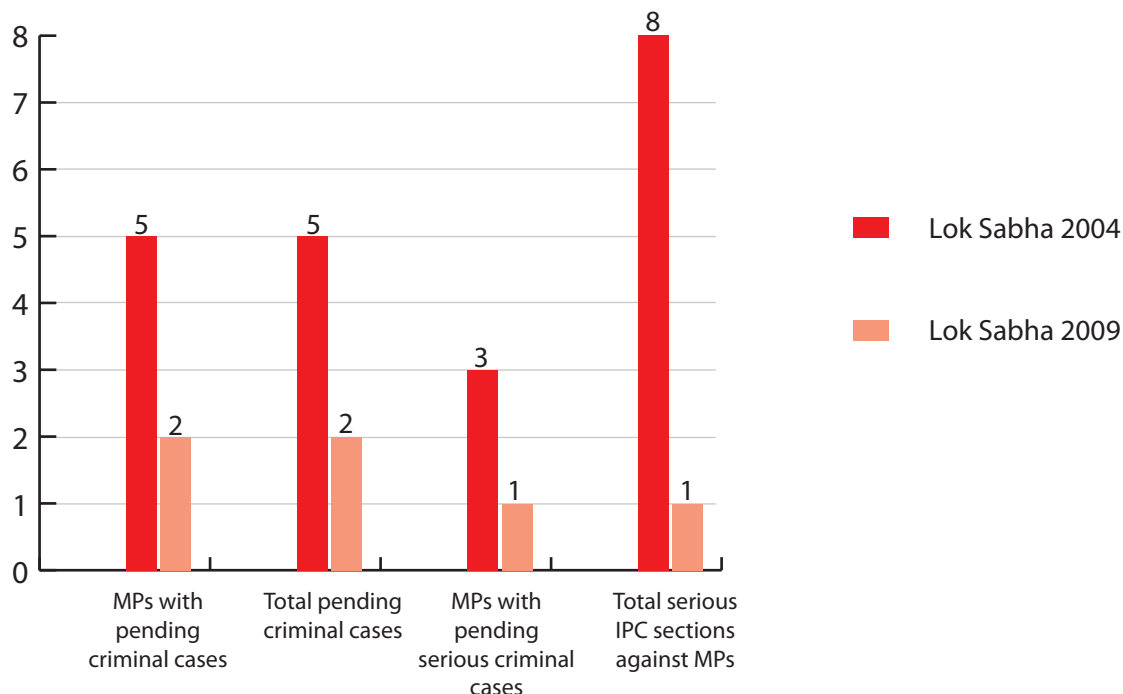
Out of the 13 MPs from Punjab in Lok Sabha 2009, 2 MPs have pending criminal cases against them. Out of these 2 MPs, pending serious criminal case is against 1 MP. Contrasting this with Lok Sabha 2004, there has been a decline in number of MPs with pending criminal cases.

Given below is a comparative analysis for MPs with pending criminal cases elected from Punjab. The presence of MPs with pending criminal cases from Punjab in Lok Sabha 2009 has decreased by 60%.

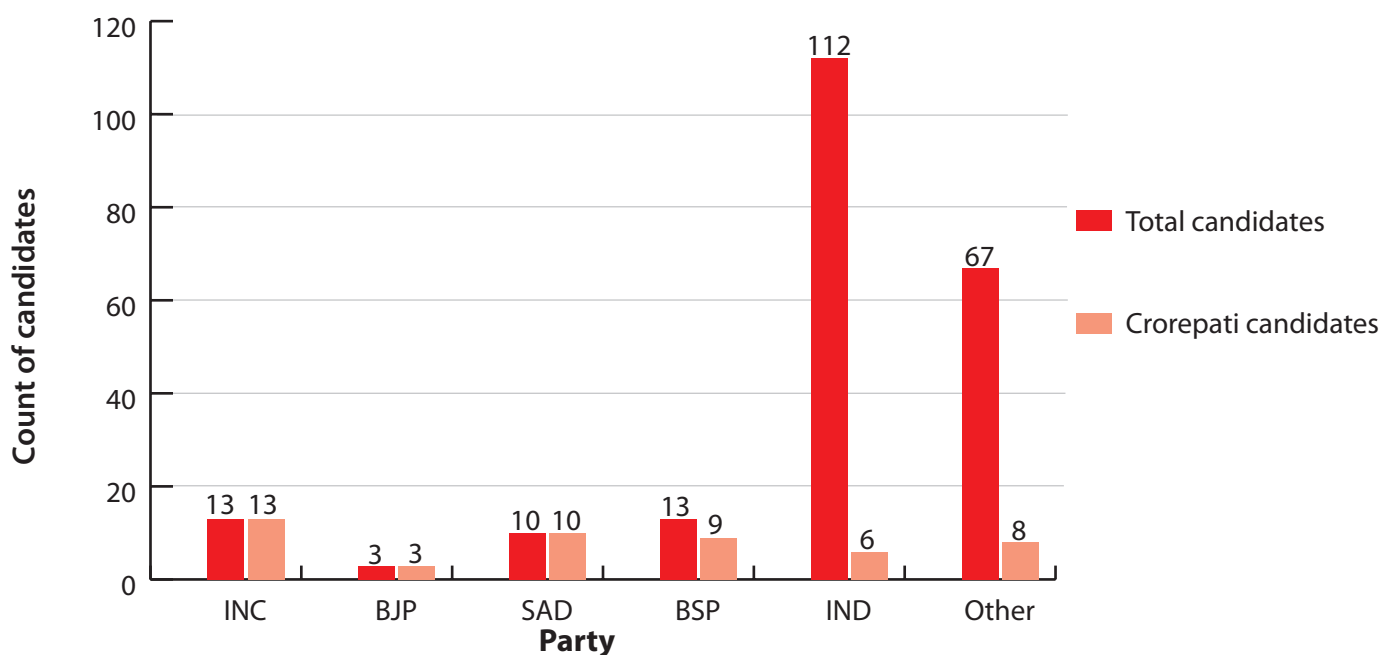

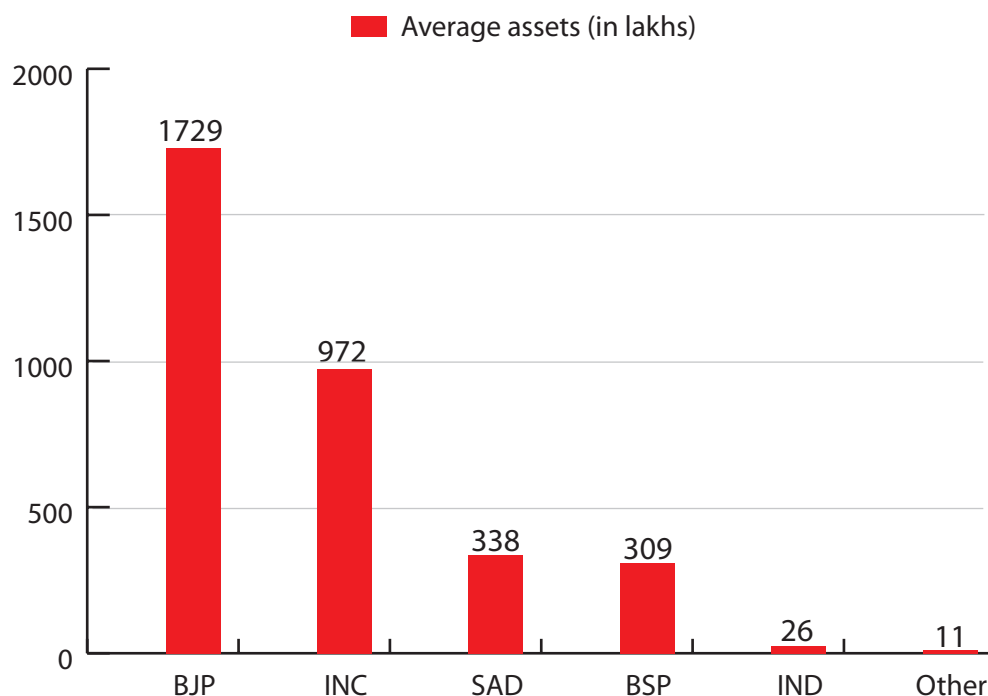

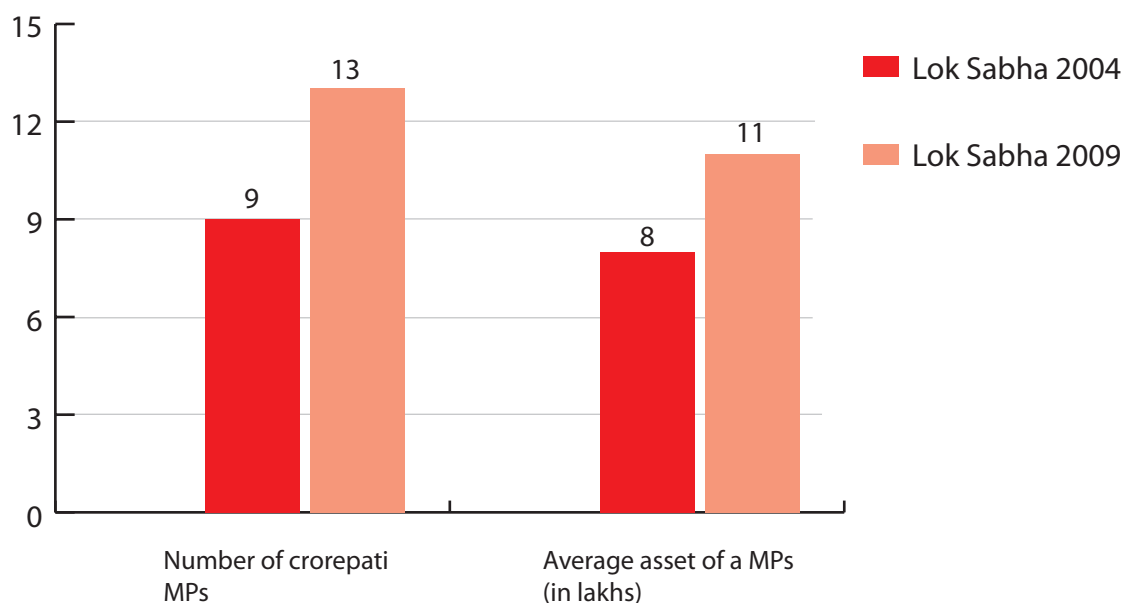
## Analysis based on assets- for MPs

All the 13 MPs in Lok Sabha 2009 from Punjab are crorepatis as compared to 9 crorepati MPs from Lok Sabha 2004, i.e. an increase of 44%. The average asset of a MP in Lok Sabha 2004 was Rs 7.98 crores which rose to Rs 11.39 crores in 2009. Between 2004 & 2009 there has been an average asset increase of 38 % for MPs.

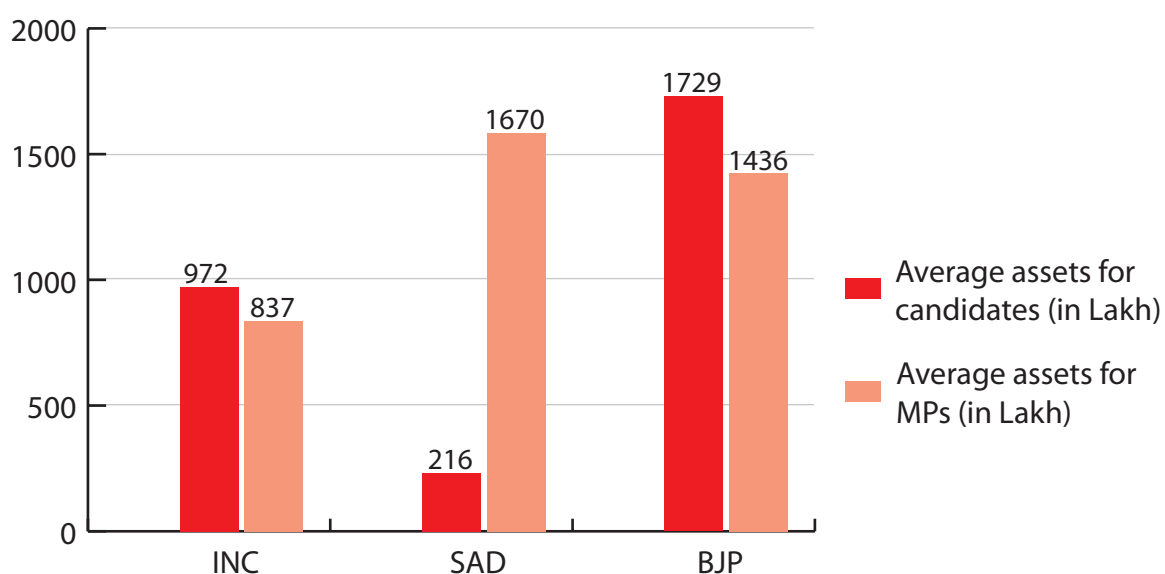

**Figure: Comparison average assets for candidates & MPs in Lok Sabha 2009**



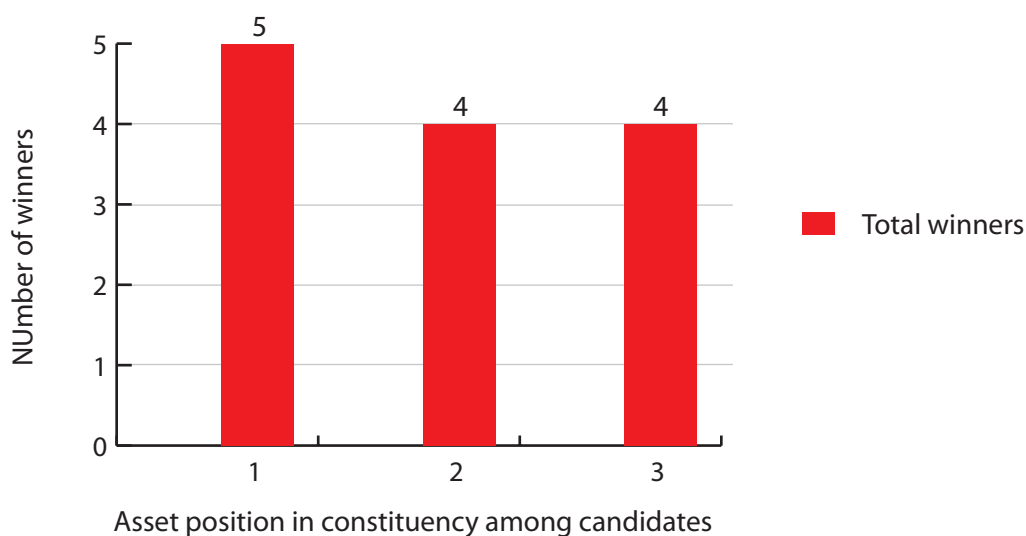
## Asset position in constituency among candidates and chances of winning

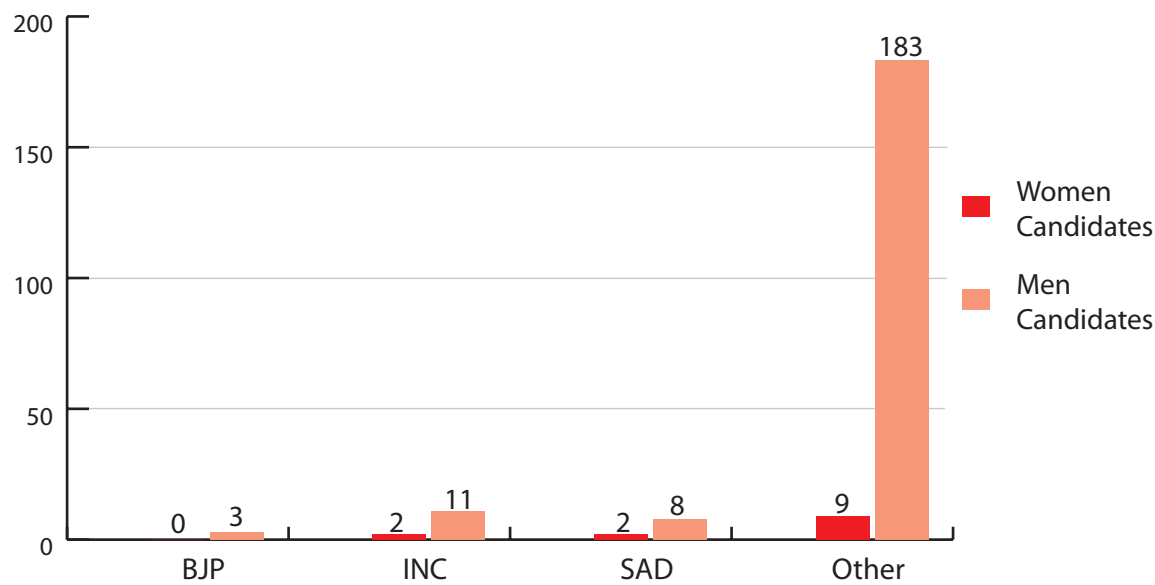
# Female representation in Lok Sabha 2009 elections
