Summary and Highlights

The **Punjab Election Watch** and **Association for Democratic Reforms (ADR)** have analysed the self-sworn affidavits of **277 out of 278** candidates, who are contesting in the following constituencies in the Punjab Lok Sabha Phase **VII** Elections.

One candidate namely Surjit Singh, a Shiromani Lok Dal Party candidate from Khadoor Sahib Constituency has not been analysed due to the unavailability of his properly scanned and complete affidavit on the ECI website, at the time of making this report.

Criminal Background

- **Candidates with Criminal Cases:** Out of 277 candidates analyzed, 39 (14%) candidates have declared criminal cases against themselves.

Candidates with Serious Criminal Cases: 29(10%) candidates have declared serious criminal cases against themselves.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Number of re-contesting MPs:** Number of re-contesting MPs analysed in the Punjab Lok Sabha elections of 2019 is **10**.
- **Average assets of re-contesting MPs in 2014:** The average assets of re-contesting MPs in 2014 was **Rs 18.23 crores**
- **Average assets of re-contesting MPs in 2019:** The average assets of re-contesting MPs in 2019 is **Rs 29.09 crores**.
- **Average growth in assets of re-contesting MPs from 2014 to 2019:** The growth in average assets of re-contesting MPs is **Rs 10.85 crores i.e. by 60%**.
