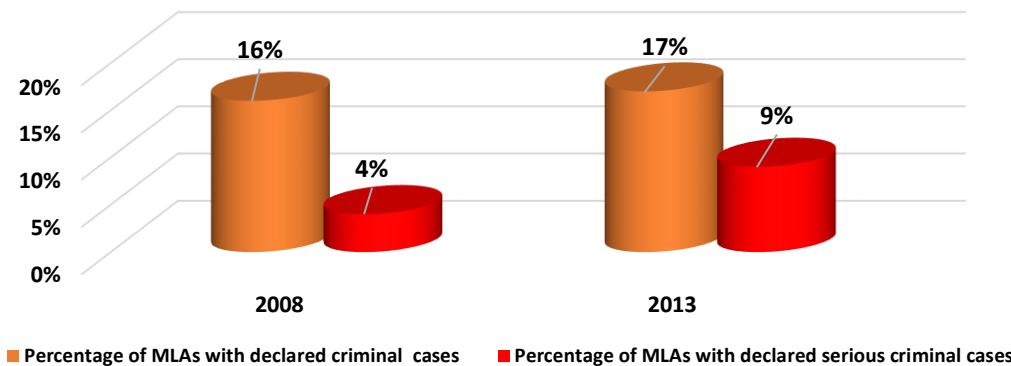

- ☛ विधायकों द्वारा घोषित आपराधिक मामले:—197 में से 34 (17 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। **2008, राजस्थान विधानसभा चुनाव में 197 में से 31 (16 प्रतिशत)** विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये थे।
- ☛ विधायकों द्वारा घोषित गंभीर आपराधिक मामले:—18 (9 प्रतिशत) विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं। **2008, राजस्थान विधानसभा चुनाव में 197 में से 8 (4 प्रतिशत)** विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये थे। जिनमें हत्या, अपहरण से सम्बन्धित अपराध इत्यादि शामिल थे।

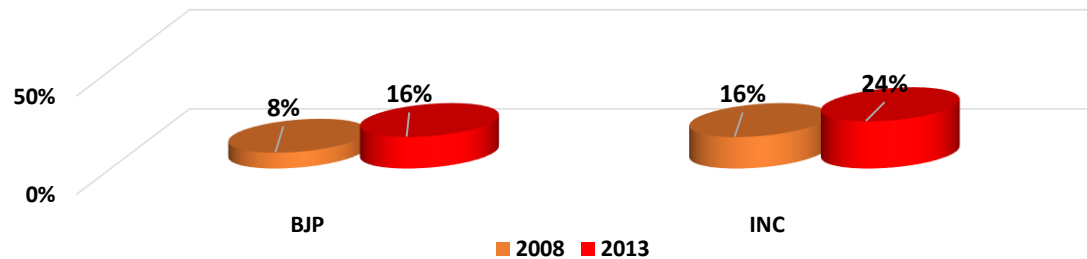

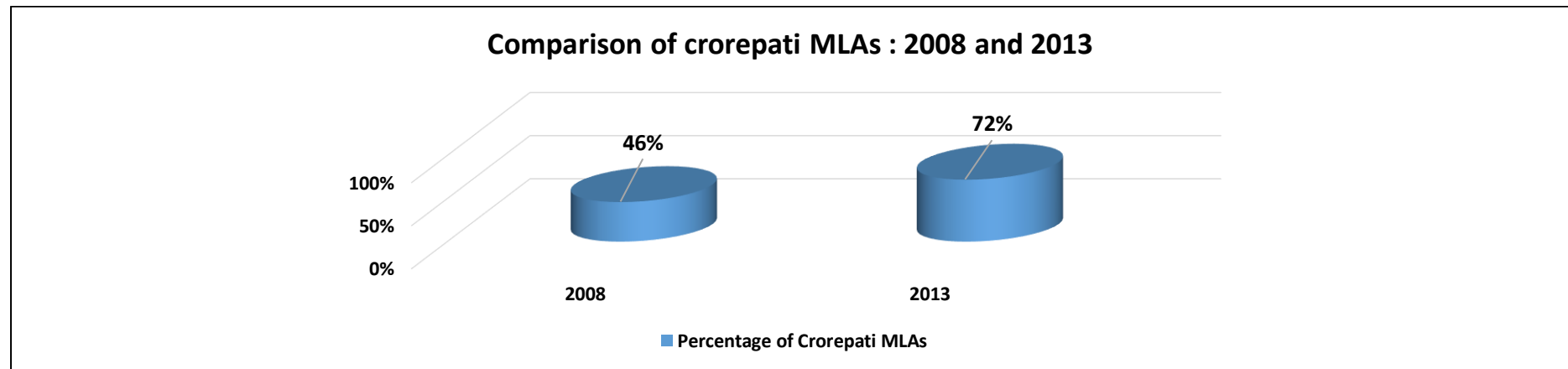

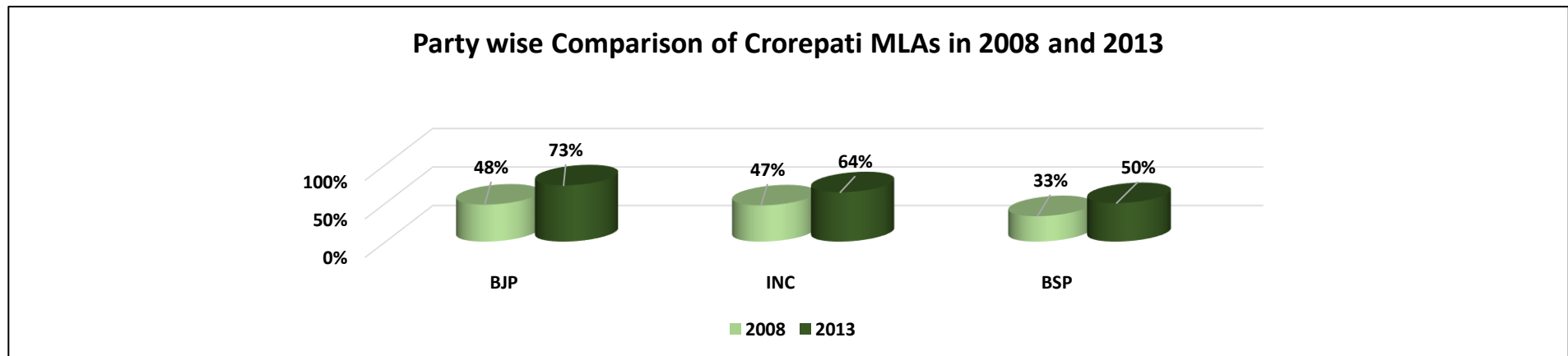

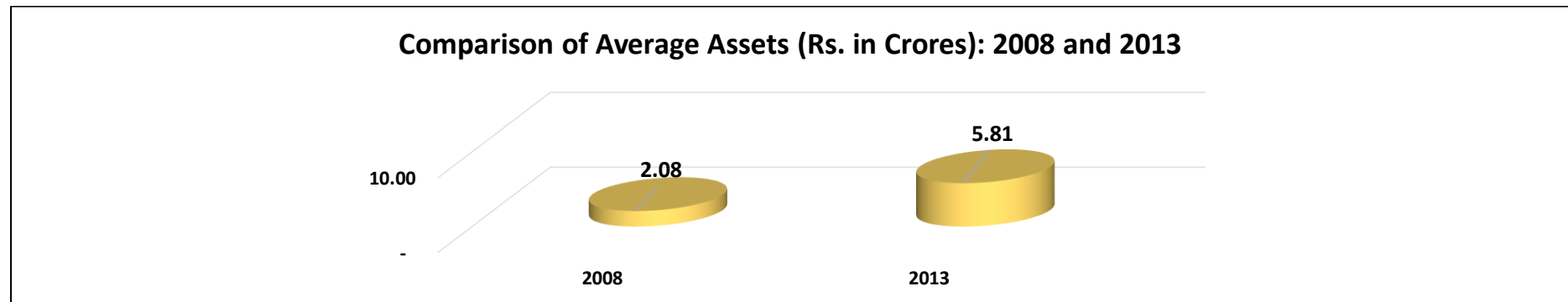
