#### Summary of MLAs and Ministers with declared criminal cases

Madhya Pradesh Election Watch (MPEW) has analyzed affidavits of the 219 MLAs (out of the maximum 230) of Madhya Pradesh 2008 Assembly Elections. Affidavits of 9 MLAs have not been analyzed since they are either incomplete or badly scanned. 2 seats of the Assembly is currently vacant (Keolari and Neemuch).

- MLAs with Criminal Cases: Out of these 219 MLAs analyzed for Madhya Pradesh Assembly Elections, 55 MLAs or 25% have declared criminal cases against them.
- Party wise MLAs with Criminal Cases: Out of 62 MLAs of INC- 21(34%) have declared criminal cases, out of 142 MLAs of BJP- 28 (20%) have declared criminal cases, out of 7 MLAs of BSP- 3 (43%) have declared criminal cases, out of 4 MLAs of BJSH- 2 (50%) has declared criminal case, out of 1 MLA of SP- 1 (100%) has declared criminal cases against him.
- MLAs with serious criminal cases: Out of the 55 MLAs who have declared criminal cases against themselves, 25 (11%) MLAs declared serious criminal cases against themselves.
- MLAs with Heinous and Violent crimes cases: The top three MLAs from major parties who have declared serious criminal cases of attempt to murder, kidnapping and theft against them are: (1) Paras Ram Mudgal of BSP from Morena constituency who has declared 1 charge related to murder. (2) Moti Kashyap of BJP from Barwara constituency has declared 1 charge related to selling minor for purposes of prostitution, etc. (3) Abhay Kumar Mishra of BJP from Semariya constituency has declared 1 charge related to kidnapping.
- Ministers with declared criminal cases: Out of the 31 current Ministers from the Madhya Pradesh Assembly, 4 have declared criminal cases against themselves, namely Kailash Vijayvargiya, Ajay Vishnoi, Umashanker Gupta and Babulal Gaur.
