Summary and Highlights

The **Tamil Nadu Election Watch** and **Association for Democratic Reforms (ADR)** have analysed the self-sworn affidavits of **802** out of **845** candidates, who are contesting in the Tamil Nadu Lok Sabha Elections.

Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- 3. If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- Offences that are assault, murder, kidnap, rape related
- 6. Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption Act
- 8. Crimes against women.
