#### रिपोर्ट के मुख्य अंश

एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स और तेलंगाना इलेक्शन वॉच ने तेलंगाना विधानसभा के 119 में से 118 वर्तमान विधायकों के वित्तीय, आपराधिक एंव अन्य विवरणों का विश्लेषण किया। वर्तमान विधानसभा में एक निर्वाचन क्षेत्र सिकंदराबाद कैंट में सीट रिक्त हैं। यह विश्लेषण 2018 के विधानसभा चुनावों और उसके बाद हुए उपचुनावों में उम्मीदवारों द्वारा प्रस्तुत शपथपत्रों पर आधारित है।

#### वर्तमान विधायक जिन्होंने राजनीतिक दल बदल लिया (11 अक्टूबर 2023 तक)

2018 के विधानसभा चुनाव के बाद 16 वर्तमान विधायकों ने अपनी पार्टी बदल ली थी। उसका विवरण नीचे दिया गया है।



#### आपराधिक पृष्ठभूमि

- विधायकों द्वारा घोषित आपराधिक मामले:— 118 में से 72 (61 प्रतिशत) वर्तमान विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये है।
- **ि विधायकों द्वारा घोषित गंभीर आपराधिक मामले**:— **46 (39 प्रतिशत)** वर्तमान विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये है।
- हत्या से सम्बन्धित मामले घोषित करने वाले विधायकः 7 वर्तमान विधायकों ने अपने ऊपर हत्या (आईपीसी—302) से सम्बन्धित मामला घोषित किया है।
- मिहलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले विधायकः 4 वर्तमान विधायकों ने मिहलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किये हैं। इन 4 वर्तमान विधायकों में से 1 वर्तमान विधायक ने अपने ऊपर बलात्कार (आईपीसी—376) से सम्बन्धित मामला घोषित किया हैं।
- क र्वर्तमान विधायकों द्वारा घोषित आपराधिक मामले—दलवारः BRS के 101 में से 59 (58 प्रतिशत), AIMIM के 7 में से 6 (86 प्रतिशत), INC के 6 में से 4 (67 प्रतिशत), BJP के 2 (100 प्रतिशत) और 2 में से 1 (50 प्रतिशत) निर्दलीय विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये है।
- कि वर्तमान विधायकों द्वारा घोषित गंभीर आपराधिक मामले—दलवारः BRS के 101 में से 38 (38 प्रतिशत), AIMIM के 7 में से 2 (29 प्रतिशत), INC के 6 में से 3 (50 प्रतिशत), BJP के 2 (100 प्रतिशत) और 2 में से 1 (50 प्रतिशत) निर्दलीय विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये है।



- चुनाव से सम्बन्धित अपराध (धारा 171 अथवा रिश्वतखोरी)
- 4. सरकारी खजाने को नुकसान पहुंचाने से सम्बन्धित अपराध
- हमला, हत्या, अपहरण, बलात्कार से सम्बन्धित अपराध
- लोक प्रतिनिधित्व अधिनियम में उल्लेखित अपराध (धारा 8)
- 7. भ्रष्टाचार निरोधक अधिनियम कानून के तहत अपराध
- 8. महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध








आलेख-विधायकों द्वारा घोषित आपराधिक मामले-दलवार प्रतिशत





## वित्तीय पृष्ठभूमि

- **करोड़पति विधायक—दलवार**: **BRS** के 101 में से 93 (92 प्रतिशत), **AIMIM** के 7 में से 5 (71 प्रतिशत), **INC** के 6 में से 4 (67 प्रतिशत), **BJP** के 2 (100 प्रतिशत) और **निर्दलीय** 2 (100 प्रतिशत) विधायक करोड़पति हैं। (घोषित संपत्ति ₹ 1 करोड़ से ज़्यादा)।







एडीआर, भारत के चुनाव आयोग के साथ जमा किए गए शपथपत्रों से चुनाव के समय उम्मीदवारों द्वारों प्रस्तुत की गई पृष्ठभूमि की जानकारी के विश्लेषण और प्रसार में अत्याधिक सावधानी बरतता है। इस तरह की जानकारी का उद्देश्य केवल राजनीति में बढ़ती आपराधिकता, चुनावों में धन के दुरुपयोग में वृद्धि को उजागर करना है ताकि पारदर्शिता, जवाबदेही और सुशासन की व्यवस्था को सुगम बनाया जा सके और मतदाताओं को एक सूचित विकल्प बनाने में सक्षम बनाया जा सके। इसलिए, यह अपेक्षा की जाती है कि इस रिपोर्ट का उपयोग करने वाला कोई भी व्यक्ति एडीआर द्वारा उपलब्ध कराए गए डेटा का उपयोग करते समय अत्यधिक सावधानी बरतेगा। एडीआर डेटा में किसी भी तरह के गलत इस्तेमाल, परिवर्तन, समझने में असमर्थता, गलत व्याख्या या हेरफेर के लिए जिम्मेदार नहीं है जिससे किसी विशेष राजनीतिक दल या राजनेता या उम्मीदवार को निशाना बनाया जा सके।
