



Analysis of Cabinet Ministers of Uttarakhand (2012-2017)

Executive Summary

- National Election Watch (NEW) has analyzed the affidavits of 10 newly appointed cabinet ministers, submitted to the Election Commission of India from the state of Uttarakhand.
- 40% ministers i.e. (4 out of 10 analyzed) have self declared criminal cases as per their affidavits filed during the recently concluded Assembly Elections.
- 2 or 20% ministers out of these 10 analyzed have declared serious IPC charges like rape, murder, attempt to murder, kidnapping, dacoity against them.
- Among these 4 Ministers who have declared criminal cases against themselves, the following Ministers have declared the highest number of criminal cases against them: 1) DINESH AGARWAL (of INC from Dharampur) has declared 2 cases against himself including 1 charge related to bribery and 1 charge related to false statement in connection with Election. 2) PRITAM SINGH (INC MLA from Chakrata) has declared 2 criminal cases against himself including 1 charge related to bribery. And 3) SURENDRA RAKESH (of INC from Bhagwanpur) has declared 2 criminal cases.
- 7 out of 10 analyzed or 70% cabinet ministers are crorepatis
- AMRITA RAWAT of INC from Ramnagar constituency has the highest assets (Rs. 13.57 Crores) among the Uttarakhand cabinet ministers followed by INDIRA HRIDYESH of INC from Haldwani constituency with assets worth Rs.5.65 Crores followed by YASHPAL ARYA of INC MLA from Bazpur Constituency with assests worth Rs. 4.52 Crores among the Uttarakhand cabinet ministers.
- The average asset of a minister in Uttarakhand comes out to be 3.29 crores.
- MANTRI PRASAD NAITHANI, an independent MLA in Uttarakhand with assets worth 32.55 lakhs, has the lowest assets among all the ministers analyzed in Uttarakhand.
- Among all the 10 ministers analyzed, only 2(20) are women minister.

Background

Association for Democratic Reforms (ADR) and National Election Watch (NEW), a nationwide campaign comprising of more than 1200 NGOs and other citizen led organizations, has been working on electoral reforms, improving democracy and governance in India. National Election Watch (NEW) has analyzed the affidavits of 10 cabinet ministers in Uttarakhand.

This report is based on the analysis of these affidavits. The following pages give analysis of criminal, financial and other background information of the Ministers.

Analysis Based on Declared Criminal Cases against Ministers

- 40% ministers i.e. (4 out of 10 analyzed) have self declared criminal cases as per their affidavits filed during the recently concluded Assembly Elections. 2 or 20% ministers out of these 10 analyzed have declared serious IPC charges like rape, murder, attempt to murder, kidnapping, dacoity against them.
- Among these 4 Ministers who have declared criminal cases against themselves, the following Ministers have declared the highest number of criminal cases against them: 1) DINESH AGARWAL (of INC from Dharampur) has declared 2 cases against himself including 1 charge related to bribery and 1 charge related to false statement in connection with Election. 2) PRITAM SINGH (INC MLA from Chakrata) has declared 2 criminal cases against himself including 1 charge related to bribery. And 3) SURENDRA RAKESH (of BSP from Bhagwanpur) has declared 2 criminal cases.

- AMRITA RAWAT of INC from Ramnagar constituency has the highest assets (Rs. 13.57
 Crores) among the Uttarakhand cabinet ministers followed by INDIRA HRIDYESH of INC from
 Haldwani constituency with assets worth Rs.5.65 Crores followed by YASHPAL ARYA of INC
 MLA from Bazpur Constituency with assests worth Rs. 4.52 Crores among the Uttarakhand
 cabinet ministers.
- The average asset of a minister in Uttarakhand comes out to be 3.29 crores.
