

Analysis of Candidates Contesting in Uttarakhand 2012 Assembly Elections (32 pages in this report)

Executive summary

- Uttarakhand Election Watch (UEW) has analyzed affidavits of 278 candidates out of 788 candidates who are contesting the 2012 Assembly Elections.
- Out of these 278 candidates analyzed, 53 candidates (i.e. 19%) have declared criminal cases against them. In 2007 assembly elections, 18% of candidates had declared criminal cases against themselves.
- Amongst major parties, every party has given tickets to candidates with pending criminal cases. INC has 16 out of 70 (i.e. 23%) candidates with pending criminal cases, BSP has 14 out of 70 (20%), BJP had 13 out of 70 (19%) and UKD(P) had 7 out of 44 (16%) candidates with pending criminal cases against them.
- Out of these 53 candidates with pending criminal cases, 14 candidates have pending serious criminal cases like extortion, theft, bribery and attempt to murder.
- A total of 88 candidates out of 278 analyzed (32%) are crorepatis. In the 2007 assembly elections, only 11% candidates were crorepati.
- 1 candidate (Dinesh Arya, UKD (P), Gangolihat) out of 278 analyzed has declared zero assets.
- A total of 43 candidates out of 278 analyzed declared liabilities of more than 20 lakhs.
- Among major parties, the average asset of a candidate for BJP is Rs 1.45 crores and for INC is Rs 1.46 crores, for BSP is Rs 1.19 crore and for UKD (P) is Rs 38.08 lakhs.
- 181 candidates out of 278 analyzed i.e. 65% are graduates or have higher educational qualifications.
- Out of 788 candidates, only 62 candidates (i.e. 7.9 %) are women; the number of women candidates for BJP is 6 out of 70 candidates (9%), for INC it is 8 out of 70 candidates (11%), for BSP it is 3 out of 70 candidates (4%) and for UKD (P) it is only 3 out of 44 candidates (7%).

Dehradun/Delhi, January 23rd, 2011: Association for Democratic Reforms (ADR) and Uttarakhand Election Watch (UEW), the Uttarakhand chapter of National Election Watch (NEW), a nationwide campaign comprising of more than 1200 NGOs and other citizen led organizations, has been working on electoral reforms, improving democracy and governance in India. Uttarakhand Election Watch (UEW) has analyzed affidavits of candidates contesting in Uttarakhand 2012 Assembly Election. This report is based on the analysis of these affidavits. There are a total of 70 constituencies going for polls in Uttarakhand 2012 Assembly Elections. The following pages give party- wise and candidate-wise analysis of criminal, financial, education, age, gender and other background information of the contesting candidates.

Number of parties and candidates

In 2007 Uttarakhand Assembly Elections, 38 parties had contested the elections. Compared to this, in the 2012 elections, 45 parties are contesting elections; this reflects an increase of 18% in the number of contesting parties.

A total of 785 candidates contested in 2007 Assembly Election while 788 candidates are contesting in 2012 Assembly Elections. Thus the number of contesting candidates has remained more or less the same between these two elections.

Analysis based on pending criminal cases- candidates

A total of 278 affidavits have been analyzed by Uttarakhand Election Watch (UEW) for 2012 Assembly Elections. Out of these 278 analyzed candidates, 53 (19%) have declared that they have pending criminal cases against them. Out of these 53 candidates with pending criminal cases, 14 have declared that they have serious criminal cases like theft, extortion, bribery, murder etc. pending against them.

Party-wise break up of candidates with pending criminal cases

A total of 53 candidates contesting elections from Uttarakhand have pending criminal cases against them. 16 (23%) out of 70 candidates analyzed of INC, 14 (20%) out of 70 analyzed candidates from BSP, 13 (19%) out of 70 candidates analyzed from BJP and 7 (16%) candidates out of 44 of UKD (P) have pending criminal cases against them. The party wise break up is given below:

Party-wise comparison of pending criminal cases on candidates in the Uttarakhand Assembly Elections 2007 vs 2012

A comparison between candidates with pending criminal cases in Uttarakhand Assembly Elections held in 2007 and 2012 respectively shows that for major parties like INC, BJP, BSP and the number of candidates with pending criminal cases has increased in 2012 elections as compared to the 2007 Assembly Elections.

Analysis based on assets

Out of 278 candidates analysed in Uttarakhand 2012 Assembly Elections, 88 (32%) candidates are crorepatis. 46 % of candidates from INC are crorepatis while around 36% of BJP candidates are crorepati. The number of crorepati candidates in 2007 was 11%.
