Summary and Highlights

The West Bengal Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **all 18** candidates, who are contesting in the **Coochbehar and Alipurduar constituency in the West Bengal Phase I Elections**.

Criminal Background

- **Candidates with Criminal Cases:** Out of **18** candidates analyzed, **6(33%)** candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **6(33%)** candidates have declared serious criminal cases against themselves.

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Financial Background

- **Crorepati Candidate**: Out of the **18** candidates, **1 candidate** namely **Paresh Chandra Adhikary(AITC)** from **Coochbehar constituency** has assets worth more than Rs. 4 crores.
- **Average assets**: The average of assets per candidate contesting in the West Bengal in Lok Sabha Phase I Elections is **Rs. 55.63 lakhs**.
- **Party wise average assets**: Among major parties, the average assets per candidate for **2 AITC** candidates is **Rs. 2.54 crores**, **2 BJP** candidates is **Rs 55.24 lakhs**, **2 INC** candidates have average assets of **Rs 47.92 lakhs**, and **2 SUCI(C)** candidates have average assets worth **Rs 6.45 lakhs**.
