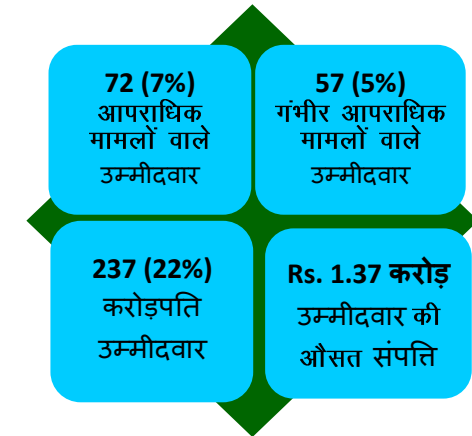

असम इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने असम विधानसभा चुनाव 2016 के दोनों चरणों में चुनाव लड़ने वाले 1064 में से 1062 उम्मीदवारों के शपथ पत्रों का विश्लेषण किया है। इस चुनाव में राजनीतिक दलों के 1064 उम्मीदवार दोनों चरणों में चुनाव लड़ रहे हैं। इस रिपोर्ट को बनाते समय दो उम्मीदवार जिनके हलफनामे निर्वाचन आयोग की वेबसाइट पर अस्पष्ट होने के कारण उनका विश्लेषण नहीं किया गया है ! नीचे उसी का सारांश दिया है

☞ उम्मीदवारों द्वारा घोषित आपराधिक मामले:- 1062 में से 72 (7 प्रतिशत) उम्मीदवारों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।

☞ उम्मीदवारों द्वारा घोषित गंभीर आपराधिक मामले:- 57 (5 प्रतिशत) उम्मीदवारों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं। जिनमें हत्या, हत्या का प्रयास, सांप्रदायिक दंगे, अपहरण, महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध इत्यादि शामिल हैं।

☞ हत्या से सम्बन्धित मामले घोषित करने वाले उम्मीदवार:- 4 उम्मीदवारों ने अपने ऊपर हत्या (आईपीसी-302) से सम्बन्धित मामले घोषित किये हैं।

8. महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध

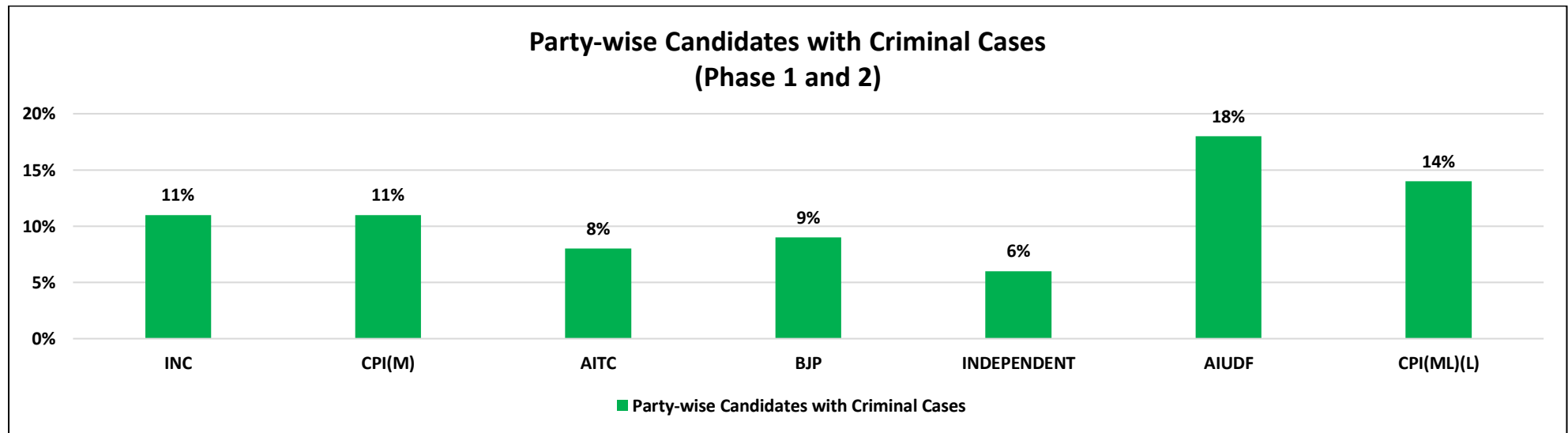

☞ **उम्मीदवारों द्वारा घोषित आपराधिक मामले—दलवार:-** कांग्रेस के 122 में से 13 (11 प्रतिशत), भाजपा के 89 में से 8 (9 प्रतिशत), ऑल इंडिया यूनाइटेड डेमोक्रेटिक फ्रंट के 74 में से 13 (18 प्रतिशत), भारतीय कम्युनिस्ट पार्टी (मार्क्सवादी) के 19 में से 2 (11 प्रतिशत) कम्युनिस्ट पार्टी ऑफ इंडिया (मार्क्सिस्ट-लेनिनिस्ट) लिबरेशन के 7 में से 1 (14 प्रतिशत) और निर्दलीय के 496 में से 31 (6 प्रतिशत) उम्मीदवारों ने अपने हलफनामे में आपराधिक मामलों घोषित किये हैं।

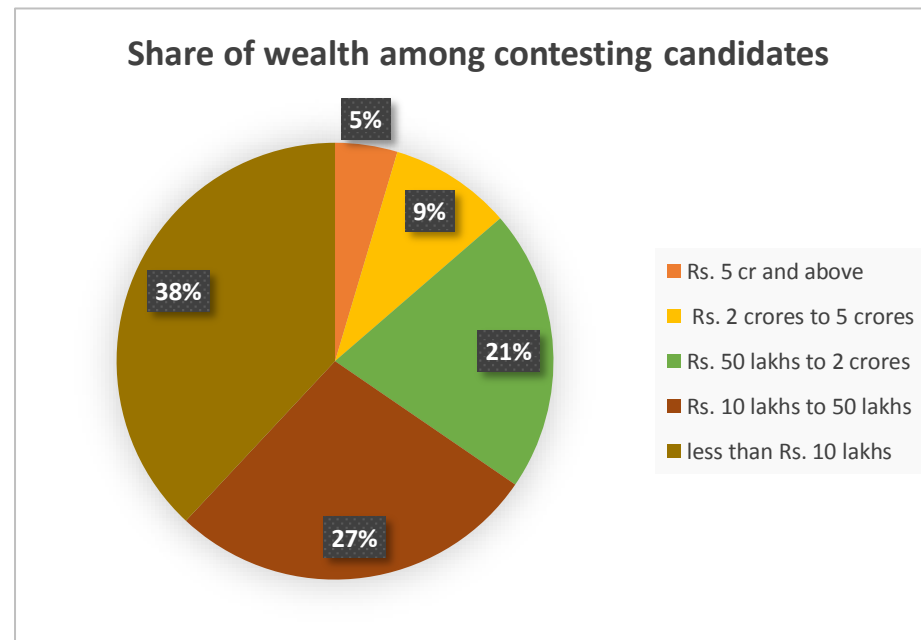

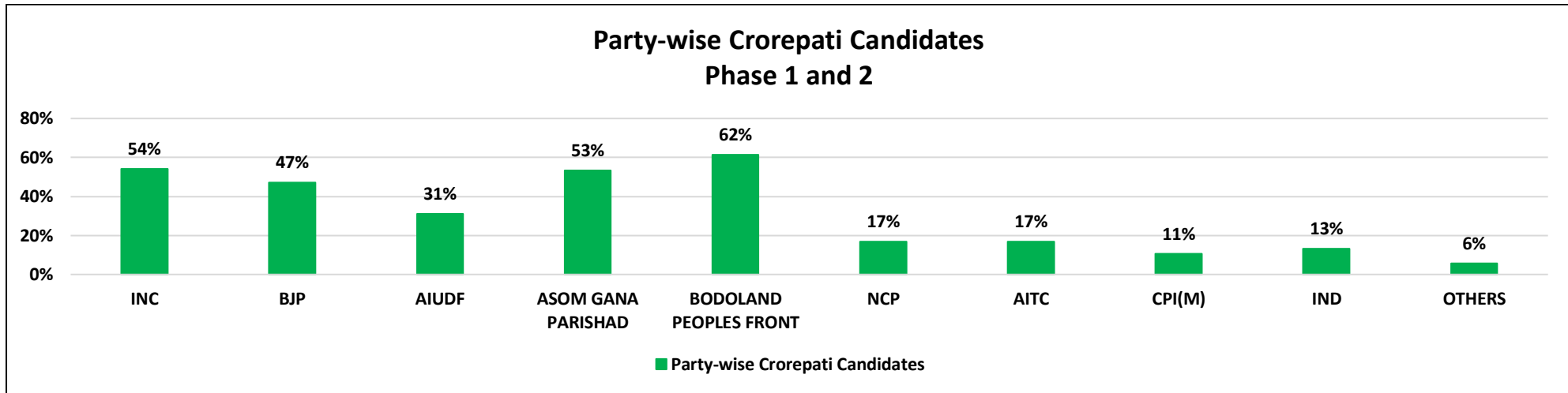

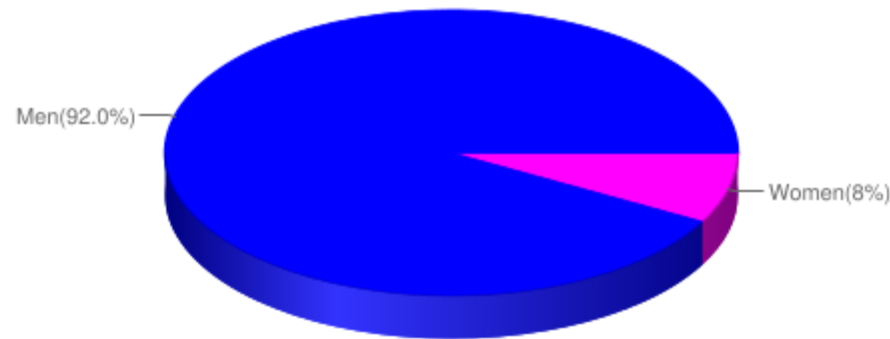
